City Manager Humora stated the 2020-2021 Mid-Biennium Budget contained necessary revisions and adjustments to the 2019-2021 Biennial Budget adopted in August 2019. City Manager Humora provided an overview of the information presented at the March 2020 Council Budget Study Session and the April 28, 2020 financial forecast update.
